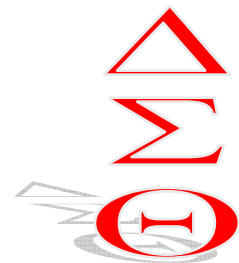

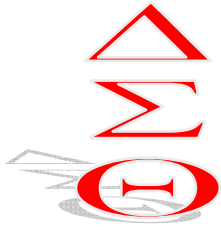

**Guidelines for Participation**

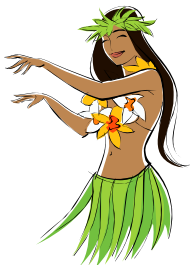
**Your cooperation with these guidelines will help ensure an enjoyable and successful event for everyone. Please adhere to all deadlines!!!!**

- Dance groups must respond to indicate participation on or by **March 15, 2009** by returning the attached form or by e-mail to designated person.
- Dance groups should prepare and perform up to a **3-minute dance routine** centered around a particular culture. (Dance routines, only)
- Dance groups should be **dressed in attire** representing and appropriate to the theme of the dance and/or culture it represents.

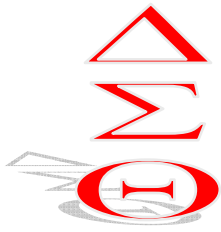
- **Dance groups MUST provide a copy of music (CD, tape, etc.) to which dance is to be performed to the International Awareness Committee by March 12, 2010** to allow time for quality duplication of one CD for the night's performances. This will eliminate much of the confusion encountered in previous years and also will ensure that music is properly recorded and playable. Dance groups will performed on a first-come basis according to the order that music is received. Music may be mailed or dropped off — please contact Ms. Wells to make arrangements or to help facilitate your providing the music for your dance.



- Dance groups **must provide a brief written description about the group and the dance to be performed**, which may include history, sponsors/advisors, members and any other relevant information. Please limit this description to one-page,. Descriptions may be e-mailed or faxed (601-979-2876) to the listed contact, by **March 12, 2010**.



- **Dance groups should arrive at Rose E. McCoy Auditorium no later than 6:30 p.m.** on the day of event and check in with appropriate hostess. Late arrival may pose a possibility of not being able to perform.
